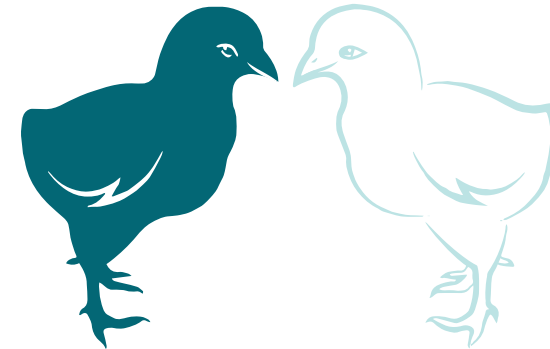

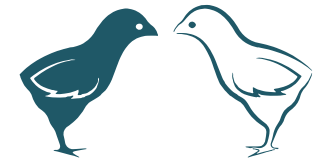

UNTIL THE AGE SPECIFIED IS REACHED, BOTH SIGNATURES WILL BE REQUIRED FOR WITHDRAWALS FROM THE ACCOUNT.

ON REACHING THE AGE OF 18 YEARS FIRST SAVERS WILL BECOME ADULT MEMBERS OF THE CREDIT UNION.

PLEASE NOTE THAT LOANS ARE NOT PERMITTED TO MEMBERS UNDER THE AGE OF 18.
